# TIMS



- **TIMS: Thuthuzela Information Management System**
- **Combines medical data, psycho-social information, and legal case information on survivors**
- **Based on existing M&E system**
  - **Southern Hemisphere**
    - ✦ **Holistic M&E System**
  - **ECI Africa**
    - ✦ **Compliance with National Protocol for PEP**

# Data System



- **Easy to use:** Data entry into a web browser
- **Familiar:** Similar to using Google – but deeper. Search for patient, View detailed patient records
- **Networked:** Sends data periodically to SOCA
- **Reliable:** Even if Internet connection is down, you may still perform data entry and view records.
- **Secure:** Login with a username/password

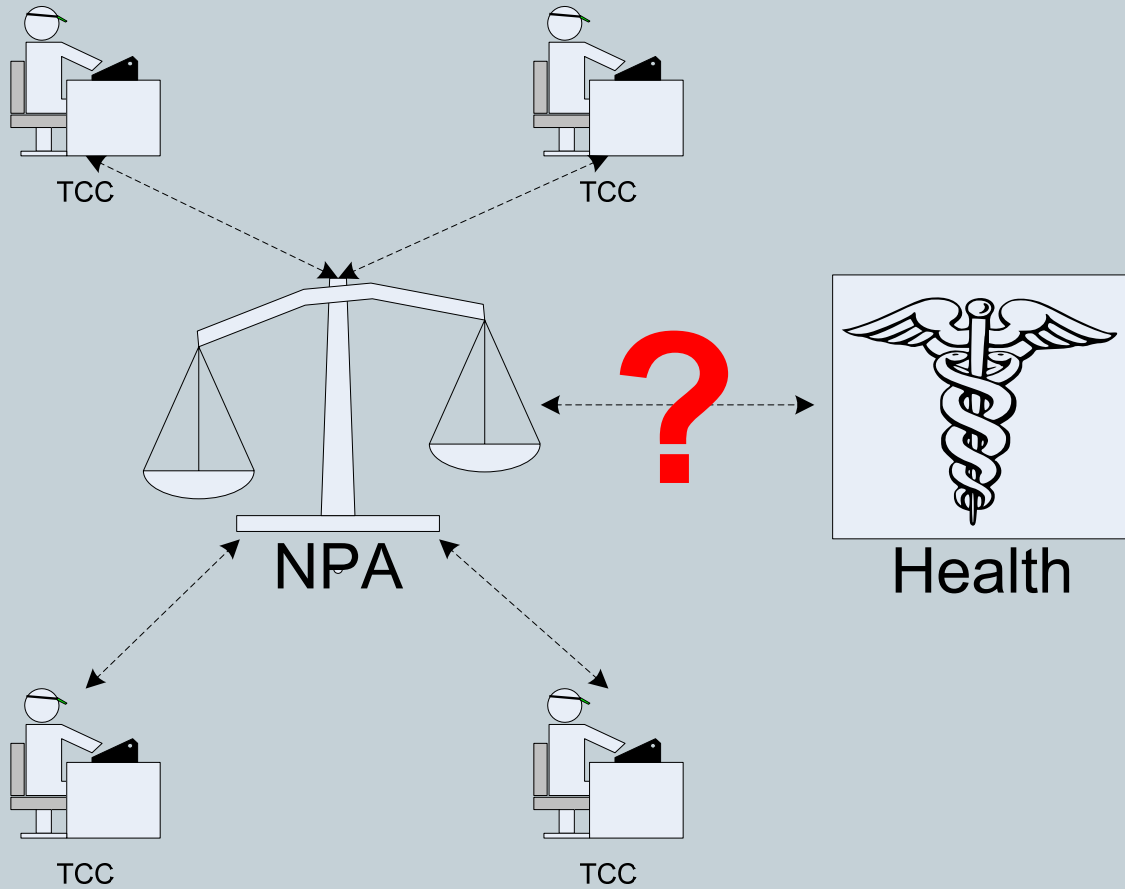
- **Pilot site 1 deployment: June**

# Data System Status



- **Currently in development**
- **Captures data for the following areas:**
  - Rape survivor contact information (demographics)
  - Intake (Intake, Relevant Medical information, Incident Details, Case Report Request)
  - Docket (Non-Arrest Docket, Arrest Docket, Further Appearance, Case Finalisation)
  - Information about the perpetrator
  - Referrals
  - Consultations
  - Court Preparation

# Operational Management



- Information from TIMS feeds into operations management at the NPA - then up to enterprise management and subsequently government.
- This data will help the NPA see how well the TCC's operate and to determine future resource identification.
  - Gap analysis for determination of resource expenditure which informs optimal capacity utilization.
