Final year law students with the courses listed above may apply provided they would have completed the degree by 1 February 2015. The programme will commence on 1 February 2015. A written contract between the National Prosecuting Authority and the Trainee Prosecutor outlining the conditions of service must be entered into and such contract will be valid and binding between the parties. The successful completion of an entry examination may form part of the selection process.

DUTIES: The Prosecutors' primary function is to conduct prosecutions and attend to matters incidental thereto. Prosecutors are the gatekeeper of criminal law. They represent public interest in the criminal justice process. When carrying out their duties, Prosecutors should at all times comply with the Code of Conduct and observe policy directives as provided for in the National Prosecuting Authority Act, 32 of 1998.
