**RE: TWO MEN SENTENCED TO FOUR LIFE TERMS FOR FOUR MURDERS**

The Western Cape High Court has sentenced Anthony Williams and Lyle Lamour to four life terms and twelve years after convicting them on four counts of murder, two counts of illegal possession of a firearm and two counts of illegal possession of ammunition. The court also sentenced Lamour to six months imprisonment for assault with intent to do grievous bodily harm after he beat up his ex-girlfriend with a wheel brace on the head. Williams also received eight years imprisonment after he attempted to murder Charles Ronald Fortune.

The court ordered that the sentences for unlawful possession of a firearm and ammunition run concurrently with the life sentences. The two convicted men executed Kelvin Mouton, Ryan Petersen, Ryan Harland and Chandre Minnies by shooting them at point blank range.

Williams had a relation with Bianca Elbrink but it ended. The two fought every now and then. Bianca entered into a relationship with a 26s gang member, Mouton. The spate of the brutal murders seem to have started from this broken affair and made worse after Bianca linked up with Mouton.

State witness, Edwina, who was under witness protection when she testified, says she and the deceased were drinking wine in her house at 6 Angelier Court, Kestrel Road, Parkwood. She told the court that she and Mouton were talking in the bedroom when Williams kicked open the door of the bedroom. Edwina scolded and swore at him and kicked it closed again. Williams kicked the door open again and she tried to kick it close again but he put his foot in the doorway and said that he wanted to speak to Kelvin.

He told Mouton 'jy moet jou frans dissipline' referring to Edwina. Mouton pushed Williams out of the house and locked the door. Edwina went to the toilet and Mouton sat in the

passage in front of the toilet. Petersen and Harland were still drinking while Minnies was asleep on the bed in the living room.

About 10 minutes later, there was a knock on the door and Mouton asked who was at the door. Williams replied that he wanted to speak to Mouton and that he should open the door. After entering the house, Williams asked for Edwina. At the time, Edwina was standing inside the bedroom when she saw Williams standing in the living room about 3m away from her. Mouton told Williams that he cannot speak to Edwina and as he turned around, Williams shot him.

During this time, Lamour was standing at the door. She saw Williams put a pillow on Minnies' face and shot her. She then heard a number of shots in rapid succession, which she said, sounded like a 'machine gun'. She then heard Williams and Lamour running down the stairs. She said that she was very scared and had wet herself.

Williams shot at Charles Ronald Fortune as they ran away from the scene of the murders.

Advocate Evadne Kortje who argued for life sentences on all the murders said: "I am satisfied with the sentences and the families are also happy with the sentences."
